<p><u>Masks</u></p> <ul style="list-style-type: none"> Surgical masks must be worn when working within 1.5m of a client indoors at a Respite Centre Masks do not need to be worn when not providing direct client care. <p><u>Vaccinations</u></p> <ul style="list-style-type: none"> Must have up-to-date Influenza vaccination Must be fully vaccinated against COVID-19 <p><u>RATs</u></p> <ul style="list-style-type: none"> Must conduct a RAT test prior to commencement of work if they have been off work, through absence or rostered day off, for more than 2 days. Must conduct a RAT every 72 hours If they conduct a RAT and test positive, they must notify their line manager as soon as possible, so contact tracing can take place. If a staff member has been exposed to COVID-19, they must inform a line manager and may be advised to conduct additional testing. 	<p><u>Masks</u></p> <ul style="list-style-type: none"> Recommended to be worn <p><u>Vaccinations</u></p> <ul style="list-style-type: none"> Recommended to have up-to-date influenza and COVID vaccinations <p><u>RATs</u></p> <ul style="list-style-type: none"> Not Required to perform a RAT prior to entering a SCC(WA) facility. If they conduct a RAT and test positive, they are advised to notify their site contact as soon as possible, so contact tracing can take place. <p><u>Visitor Limits</u></p> <ul style="list-style-type: none"> No restrictions on number of visitors when there is no infectious disease outbreak Visitor restrictions may be implemented on assessment of infectious disease outbreak 	<p><u>Masks</u></p> <ul style="list-style-type: none"> Surgical masks must be worn when working within 1.5m of a client indoors at a Respite Centre Masks do not need to be worn when not providing direct client care. <p><u>Vaccinations</u></p> <ul style="list-style-type: none"> Must have up-to-date Influenza vaccination Must be fully vaccinated against COVID-19 <p><u>RATs</u></p> <ul style="list-style-type: none"> Must conduct a RAT every day they enter or work at a SCC(WA) facility If they conduct a RAT and test positive, they are advised to notify their site contact as soon as possible, so contact tracing can take place. 	<p><u>Masks</u></p> <ul style="list-style-type: none"> Masks do not need to be worn when at a Respite Centre <p><u>Vaccinations</u></p> <ul style="list-style-type: none"> Recommended to have up-to-date Influenza vaccination Recommended to be fully vaccinated against COVID-19 <p><u>RATs</u></p> <ul style="list-style-type: none"> Not Required to perform a RAT prior to entering a SCC(WA) facility. If they conduct a RAT and test positive, they are advised to notify their site contact as soon as possible, so contact tracing can take place. <p><u>Exemptions</u></p> <ul style="list-style-type: none"> Delivery drivers are not required to have up-to-date vaccinations but are recommended to wear a mask if entering the facility
